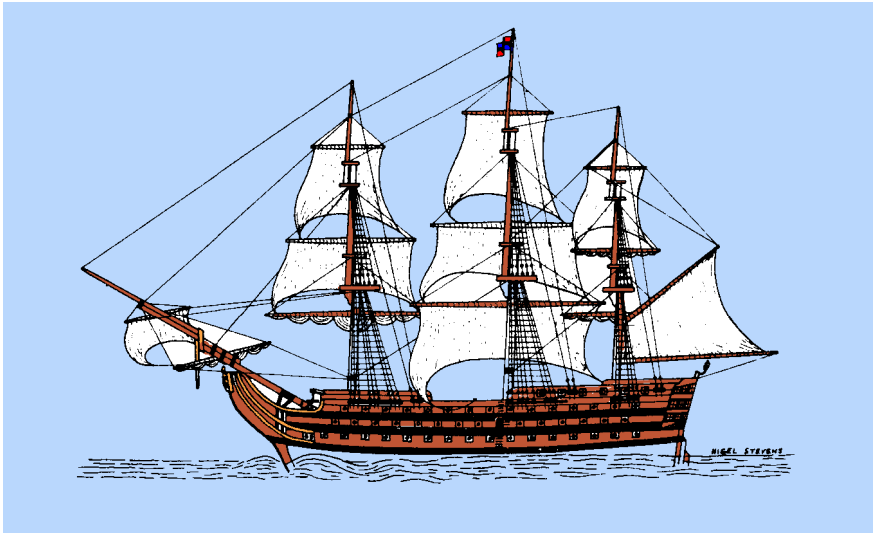

TRIAL BY JURY

It was four years after the success of "Thespis" that Richard D'Oyly Carte approached its authors, W.S. Gilbert & Arthur Sullivan to ask if they could write a curtain raiser for his production of Offenbach's "La Perichole". The result was "Trial by Jury", an opera almost unique in the whole field of opera, a short one act piece with full chorus, which fact, together with the sheer brilliance of its writing, has kept it in a strong demand as a curtain raiser.

H.M.S. PINAFORE

H.M.S. Pinafore was the second full length light opera written by Gilbert & Sullivan. This production restores several passages pruned away before the opening night, which have probably never, well hardly ever, been seen on any stage. These were discovered in the manuscript notes of W.S. Gilbert now housed in the British Museum.

It is well known that Gilbert rifled the plots of his "Bab Ballads" to gain ideas for his operas. Isaac Goldberg points out that no fewer than 10 Bab Ballads contributed to the plot of "Pinafore". One of these, "The Bumboat Woman's Story", had a character called Poll Pineapple, who became Little Buttercup, but who, years later, was restored (almost) to her original title by Charles Mackerras when he created his ballet "Pineapple Poll" to Sullivan's music.

Pinafore did not enjoy immediate success and box office receipts only improved when a selection of airs from the opera were played at a promenade concert. The resulting "hit" also took America by storm, "pirated" versions, from which productions Gilbert & Sullivan, to their rage, did not receive a penny, being played all over the States.

The opera is basically a straight Victorian love story, but the score is full of charming, pretty songs, and attractive tunes which will ensure its undying popularity. It is memorable for the magnificent Grand Operatic aria for the Soprano in Act 2, "The hours creep on", and for the quaint character study, Sir Joseph Porter, modelled on W.H. Smith, founder of the well-known chain of bookshops.

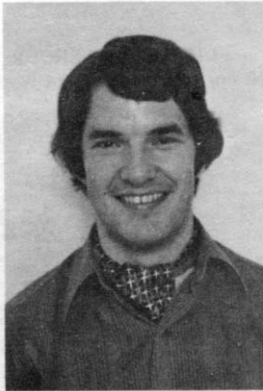

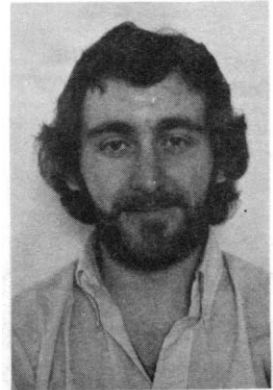

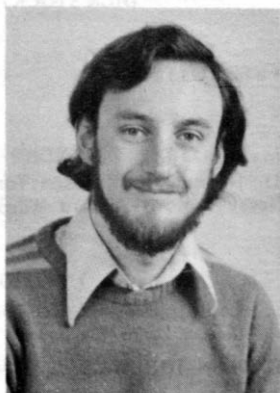

Following "The Sorcerer" and "Ruddigore", "Trial by Jury" is Ian Gledhill's third production in Budleigh. A Civil Engineer with London Transport, he appeared in the cast of three shows before taking over as producer. He is an active member of the Dvořák Society, and his other interests include Victorian Architecture and trams.

Heather Davis studied as a singer at the Royal College of Music from 1967 to 1971. Her previous appearances with the Society here in Budleigh have been in "Pirates of Penzance", "Gondoliers" (as Casilda) and "Sorcerer". Heather has also played the title role in "Patience" and portrayed Pheobe Meryll in "Yeomen of the Guard", both in the Society's London productions. Heather is married to Colin Davis, who plays the part of the Captain in this production.

Graham Burton has been a regular I.C.O.S. visitor to Budleigh since he stage-managed the first tour with Iolanthe in 1968. Although born in London, he received the majority of his education in Devon, gaining a place at Imperial whilst at Newton Abbott Grammar School. Graham graduated with a honours degree in Electrical Engineering in 1969, and is currently employed by University College London on the International Ultra-Violet Explorer Satellite project.



MUSICAL DIRECTOR DAVID POLLARD

David Pollard studied as a pianist at the Royal College of Music with Colin Horsbey, and subsequently with Kendall Taylor and Peter Wallfisch; as well as being a prizewinner there, he was selected to play a concerto with a Royal College Orchestra.

As a conductor he has given over seventy orchestral and choral concerts all over the South of England, having conducted his first orchestral concert when he was sixteen. He joined I.C.O.S. in September 1972 since when he has conducted performances of "Iolanthe", "Princess Ida", and "Trial by Jury".
