## TILEHOUSE STREET BAPTIST CHURCH MINUTE BOOK -

1802. John Grey recommended to Mr. Upton's church.	<u>March 4<sup>th</sup>.</u> At a church meeting held this day, a letter of recommendation, on behalf of our Brother John Grey, for occasional communion with the Baptist Church in London, under the pastoral care of the Rev. Mr. Upton, was read and signed.
William Kingsley suspended.	<u>December <math>2^{nd}</math></u> . At a church meeting held this day, it being reported that the conduct of William Kingsley had been dishonourable, messengers had been appointed to converse with him upon the subject.
	<u>December 30<sup>th</sup></u> . At a church meeting held this day, the messengers who had been appointed to converse with William Kingsley being all present, and it appearing that they had all seen him, and that his conduct had been so dishonourable that in their opinion he ought to be suspended, he was by the unanimous vote of the church suspended accordingly.
William Craft, John Farmer, and Ann Arnold excluded.	And whereas the conduct of William Craft, John Farmer, and Ann Arnold, had all been exceedingly reprehensible, not only in absenting themselves from the church, but in the abominable spirit they had manifested, and whereas they had all been conversed with by one or more of our brethren, and had manifested rather a wish to be separated from the church, than the contrary, by the unanimous vote of the church they were this day totally separated therefrom and declared to be no longer members thereof.
Messengers appointed to William Austin, and William and Sarah Bunyan.	William Austin, and Willian Bunyan and Sarah his wife, had also absented themselves from the church, messengers were appointed to speak to them on this subject.
Bullyan.	It should have been before remarked that a Definitive Treaty of Peace having been concluded between this country, France, Spain and Holland, and the first day of June having been appointed by the King's Proclamation, as a day of Public Thanksgiving on this happy account, the same was observed by the church and congregation accordingly. Three brethren engaged in prayer and thanksgiving, and a sermon was preached on the occasion from Leviticus $25: 6^{\text{th}}$ . "And I will give peace in the land." Through the great goodness of God in the merciful harvest which he granted the preceeding year we were called upon also this day to thank Him for plenty as well as peace. Thus God in his providential dealings with this country, within a few years past, has remarkably intermingled mercy with judgement.

	opportunity to do so, and the report which he made of the result of that conversation not being satisfactory, and he still continuing to act disorderly, he was this day by the unanimous vote of the church separated from, and declared to be no longer a member of the church.
Rebecca Chapman proposed to the church.	And this day, Rebecca Chapman was proposed to the church and messengers were appointed to converse with her.
Agreed that her experience should be given in to the church.	<u>May 1<sup>st</sup></u> . The church being stopped, the messengers who had been appointed to converse with Rebecca Chapman made their report concerning her, and agreeing in their hope that she was a subject of grace, it was agreed that her experience should be given in to the church, at the next church meeting.
Which is accordingly done.	<u>June <math>2^{nd}</math></u> . At a church meeting held this day, the experience of Rebecca Chapman was read before the church, and being satisfactory, it was agreed that she should be received into full communion with the church, the next Lord's Day.
And she is received into the church.	<u>Lord's Day June <math>5^{\text{th}}</math></u> . Rebecca Chapman was received into full communion with the church.
Congregational fast observed.	War having taken place between this country and France and Holland, and we being at this time particularly threatened with an invasion, this day, August 4 <sup>th</sup> was not only observed as a church meeting, and harvest meeting, but as a day of fasting and prayer, by the church and congregation. Three brethren, besides the pastor, engaged in prayer, upon the occasion.
National fast observed.	<u>October 19<sup>th</sup></u> . Being appointed by the King as a National fast day, was observed by the church and congregation, as a day of fasting and prayer. Four brethren engaged in prayer, and a sermon was preached on the occasion, from Isaiah 3: 10,11 "Say ye to the righteous, that it shall be well with him: for they shall eat the fruit of their doings. Woe unto the wicked, it shall be ill with him: for the reward of his hands shall be given him."
	At a church meeting December 29 <sup>th</sup> the transactions of the church for this year were read before the church, and signed by us in the name of the whole. John Geard. Daniel Lane. John Foster.
1804. The case of the King particularly noticed.	<u>March 1<sup>st</sup></u> . As it has pleased God particularly to afflict our King, our church meeting held this day, was more especially spent in prayer to God, on his behalf, and his case was affectionately recommended to the notice of the King of Kings. Three brethren, besides the pastor, engaged in prayer. May these prayers and those of others on his behalf be mercifully answered.
	At this church meeting, an opportunity having been previously had by one of our brethren, who was appointed at the preceeding church meeting so to do, to converse with William Bunyan and Sarah his wife, who have for a long time absented themselves from the church, they were both declared to be no longer members with us. And Daniel Field and Thomas Button who had each of them been previously conversed with by the appointment of the church, having partially absented themselves from the church, they were both this day

	suspended from communion with us. And Henry Asplen and Mary Field, who are both members of the church at Little Staughton, and have had for a number of years occasional communion with us, having acted disorderly, it was agreed to forbid them to commune with us any longer, and to inform the church they belong to of our so doing.
William and David Wilshere proposed to the church.	<u>May <math>3^{rd}</math></u> . At a church meeting held this day, William Wilshere and his brother David Wilshere, sons of our sister Rebecca Wilshere, were proposed to the church, and messengers were appointed to converse with them.
National Fast observed.	<u>May 25<sup>th</sup></u> . Being appointed by the King as a National fast day, was observed by the church and congregation, as a day of fasting and prayer. Three brethren engaged in prayer, and a sermon was preached on the occasion from Genesis 18:14 "Is anything too hard for the Lord"!
Agreed that the experiences of William and David Wilshere be given in to the church.	<u>May <math>31^{\text{st.}}</math></u> At a church meeting held this day, some of the messengers who had had conversation with William and David Wilshere being present, and agreeing in their hope that they were the subjects of grace, it was agreed that their experiences should be given in to the church, at our next church meeting.
The experiences of William and David Wilshere given in to the church.	<u>June 28<sup>th</sup></u> . At a church meeting held this day, the experiences of William and David Wilshere were read before the church, and being satisfactory, it was agreed that they should be received into full communion with the church the next Lord's Day.

Collection made for the Baptist Mission.	<u>Lord's Day August 12<sup>th</sup>.</u> Mr Sutcliff of Olney preached in the morning and afternoon at Tylehouse Street Meeting. In the afternoon he made a public collection for the Baptist Mission, and, including what he received the next day, he obtained £17. 4s. In the evening he made a public collection at Back Street Meeting, for the same purpose, and obtained £10. 9s. 9½d. So that he obtained at Hitchin in all £27. 13s. 9½d.
Daniel Field and Thomas Button excluded.	<u>September 13<sup>th</sup></u> . This day was observed not only for the purpose of returning God thanks for his goodness relative to the harvest, but as an extra church meeting day, and as Daniel Field and Thomas Button had continued to absent themselves from their places, and having also declared to one of the officers of the church who had been desired to question them upon this subject, that they did not mean to return again, they were by the unanimous agreement of the church this day separated from, and declared to be no longer members of the church.
Samuel Jackson dismissed.	<u>October 4<sup>th</sup>.</u> At a church meeting held this day, a letter of dismission from this church, to the Baptist Church at Potters Bar, on behalf of our brother Samuel Jackson was signed.
Special Prayer meeting.	This meeting was also considered as a special prayer meeting, particularly for the revival of religion amongst us, and for divine direction as to the choice of

	another deacon in the room of our deceased brother James Allen, who for many years was active and useful among us in that capacity.
Brother John Foster chosen to the office of deacon.	Lord's Day October 4 <sup>th</sup> . After the administration of the Lord's Supper, the members, sisters as well as brethren, being desired to stay, Brother John Foster was nominated and unanimously chosen to the office of deacon among us.
Which he accepts.	<u>November 1<sup>st</sup></u> . At a church meeting held this day, our Brother John Foster accepted the office of deacon to which he had been unanimously chosen. It is remarkable that his father, whose name also was John Foster, who died in 1782, had been a deacon of this church about 40 years before he died, and that his grandfather, whose name likewise was John Foster, was unanimously set apart to the same office of deacon, in this same church, May 1 <sup>st</sup> 1691 upwards of 113 years ago.
William Smith suspended.	This day, William Smith of Little Almshoe, was suspended from communion with the church for drunkenness.
Sermon preached on the deacon's office.	<u>Lord's Day November 11<sup>th</sup>.</u> The pastor of the church preached a sermon upon the office of deacons from Philippians 1: $1^{st}$ "With the bishops and deacons".
John Gray dismissed. 1805.	<u>November 29<sup>th</sup>.</u> At a church meeting held this day, a letter of dismission, from this church to the Baptist Church in London, under the pastoral care of the Rev. Mr. Upton, on behalf of our Brother John Gray, was read and signed.
	At a church meeting held this January $3^{rd}$ , the transactions of the church for the last year were read before the church, and signed by us in the name of the whole.

National fast observed	<u>February 20<sup>th</sup></u> . Being appointed by the King as a National fast day, was observed by the church and congregation, as a day of fasting and prayer. Three brethren engaged in prayer, and a sermon was preached on the occasion from Judges 6:24 <sup>th</sup> "Then Gideon built an altar there unto the Lord, and called it Jehovah shalom, (the Lord send peace) unto this day it is yet in Ophrah of the abieztites".
Lydia Lightfoot suspended.	<u>January 31<sup>st</sup></u> . At a church meeting held this day, Lydia Lightfoot, who had not attended with us for a long time, was suspended by the church, and messengers were appointed to visit her.
And excommunicated.	<u>February 28<sup>th</sup></u> At a church meeting held this day the messengers who were appointed at the last church meeting to visit Lydia Lightfoot made their report concerning her, which being that she never intended to attend with us anymore, and her conduct in other respects not being honourable she was this day by the unanimous vote of all present totally separated from the church.
Thomas and Mary Wren dismissed from	<u>April 4<sup>th</sup></u> . At a church meeting held this day a letter of dismission from the Baptist church at Luton under the pastoral care of the Rev. Mr. Blundel to this

Luton church.	church, on the behalf of Thomas Wren and Mary his wife, was read, and it was unanimously agreed that they should be received into full communion with this church, the next Lord's Day.
Sarah Whitbread dismissed to the church at Potters Bar.	And this day a letter of dismission from this church to the Baptist church at Potters Bar, under the pastoral care of the Rev. Mr. Broady, on the behalf of Sarah Whitbread, was read and signed.
Thomas and Mary Wren received into the church. Robert Parker excommunicated.	Lord's Day April 7 <sup>th</sup> . Thomas and Mary Wren were received into full communion with the church.
	Whereas Robert Parker, who was suspended May ye 31 <sup>st</sup> 1792 had not only since that time not given sufficient satisfaction relative to this conduct to have that suspension removed, but has acted in a very fraudulent manner, within a comparatively short time past, he was this day, by the unanimous vote of the church, totally excluded from our communion, being the second day of May.
	It was also agreed this day, that a public collection should be made to assist the congregation meeting at Red Hill, in the parish of Sandon, in this county, relative to building a new meeting house.
Collection made towards Red Hill meeting house.	<u>Lord's Day June <math>2^{nd}</math></u> . Pursuant to the foregoing agreement, a public collection was made for the people at Red Hill, and, including what was afterwards received, the sum of £10.10s.0d. was obtained.
Public Thanksgiving observed.	December 5 <sup>th</sup> . Being appointed by the King, as a day of public thanksgiving, on account of an important victory obtained over the combined fleets of France and Spain, off Cape Trafalgar, on the coast of Spain, on the 21 <sup>st</sup> October, 1805, in consequence of which 16 of their capital ships were destroyed, and 8 eventually taken, a joint meeting was this day held by this congregation and that at Back Street at both our places of worship, in the morning at Back Street, and in the evening at Tylehouse Street. In the morning service, the pastor of this congregation prayed, and the pastor of Back Street congregation preached from Psalm 97 1, 2 "The Lord reigneth, let the earth rejoice: let the multitude of aisles be glad thereof. Clouds and darkness are round about him: righteousness and judgement are the habitation of this throne". In the evening the pastor of Back Street congregation prayed, and the postor of this congregation preached, from Psalm 107 43 "Whoso is wise and will observe those things, even they shall understand the loving kindness of the Lord". However, as in this battle, not only Admiral Lord Nelson, the commander in chief, was killed but many poor sailors were killed and wounded, and as a fund had been established in London, called the Patriotic Fund, for the relief of wounded sailors and soldiers, and the families of such as were killed, collections were accordingly made, at both our places of worship, and, including what was received afterwards, the joint sum was obtained of £13.3.2d. There was also collected at the Parish church at Hitchin, £26.0s.9d. Moreover the sum of £21.0s.0d. was afterwards communicated from the Hitchin Volunteer Infantry. Making in all £60.3s.11d.

At a church meeting, held this January 2<sup>nd</sup>, the transactions of the church for 1806 the last year, were read, and signed by us, in the name of the whole church. It is remarkable, that though it was not for certainty known, at the time when the first meeting was held, whether the King was then dead or alive, yet that he not only was recovered, but was living at the last, 20 years distant from the first. It should however, not be forgotten, that as the respective ministers and one of the deacons of each congregation, engaged in prayer, at the first time of our meeting one of the ministers, and one of the deacons, who then engaged, have since been removed, namely, the minister Mr. Griffiths, and the deacon, Mr. Wilshere, of Back Street congregation, the pastor of this congregation, and our brother Daniel Lane, deacon thereof, being still spared, and were both present, at the last meeting. Mr Williams, the present pastor of Back Street congregation began the service, by singing, making a short introduction, and prayer, and the pastor of this congregation, from 2 Peter 1:13 "Yea, I think it meet, as long as I am in this tabernacle, to stir you up, by putting you in remembrance," and concluded, with prayer and the benediction.

In the first discourse, particular notice was taken of the Jewish Jubilee and of the political and typical use and design of it, with some transient remarks on some other Jubilees: and, in the afternoon, particular notice was taken of the peculiar advantages that have been enjoyed, in this country, by Protestant Dissenters, since the glorious revolution and a King William 3 <sup>rd</sup> , and under the reigns of the Georges, of the Illustrious House of Hanover, who have swayed the sceptre of this nation, for almost a century and particularly under the reign of his present Majesty, who has now swayed the sceptre, almost half a century, and

who has not only kept the promise which he made, at his accession to the Throne, that, he would maintain the toleration inviolable, but has enlarged the privileges of Protestant Dissenters, by the act of Parliament, that was passed in the year, 1779, in favour of Protestant Dissenting Ministers and Schoolmasters. It is remarkable, that only two Sovereigns have reigned so long as his present Majesty, over the British Nation, namely Henry 3<sup>rd</sup>, who died November 16<sup>th</sup> 1272 in the 57<sup>th</sup> year of his reign, and Edward 3<sup>rd</sup> who died June 21<sup>st</sup>, 1377, in the 51<sup>st</sup> year of his reign. Neither of them however, lived so long, as his present Majesty has already, as Henry died, in the 65<sup>th</sup> year of his age, and Edward in the 66<sup>th</sup> year of his age; whereas our present King is, at this time, in the 72<sup>nd</sup> year of his age:and he has already reigned longer than any King or Queen has done, in this kingdom, for upwards of 430 years.

A Bill having been brought in to the House of Lords, by Vicount Sidmouth, to make certain alterations in the Acts of Parliament which relate to Religious Toleration, which would if carried into a law, have greatly infringed the rights and liberties of Protestant Descenters and the author of the Bill proposing to have it read a second time, on the 21s <sup>t</sup> May, such exertions were made in opposition to his Bill, that in the space of 48 hours, 336 petitions, from various congregations within 120 miles of London, were obtained, and all presented to the House of Lords, on that day, which added to 256 petitions, which were obtained, in the same space of time, by the Methodists in connection with the late Rev. John Wesley, formed an aggregate amount of nearly <b>six hundred</b> petitions, all of which were presented at the same time. No public collection having been made at our place for the Baptist Missional Society, for some years, on account of the very great expenses we have been at, relative to our new Burying ground, and the alterations of our Meeting House, and the repeated calls that have been made on our friends, on these accounts (though considerable sums have been repeatedly transmitted to that Society, which have been raised voluntarily by individuals, during that interval) these expenses having been at length surmounted, it having been previously agreed that a public collection should be made for this Society, in the course of the present year, Mr. Edmonds of Cambridge, who had been requested to officiate on this occasion, preached at our Meeting House, Lord's Day, November $23^{rd}$ , and made a collection in the afternoon, which amounted to $\pounds 16 \ 17s.\ 3^{3}$ /d. and another in the evening which amounted to $\pounds 8 \ 3s.\ 8^{1/2}d$ .
